# GB39 19/20 Chair's Business (Verbal)

- (a) Governor Assessment 2018/19;
- (b) Chair of Curriculum, Qualifications and Engagement Committee summarised key statistics in and the governance pathway for WCQIP 2019/20. Chair and Principal & Chief Executive (as Accounting Officer) signed the following submissions to DfE on behalf of Governing Body:
- Request for submission of QIP FE 2019 (003);
- Request letter to FEC s seeking annual quality assessment return (AAR) for 2019-20 (002).

The Governing Body noted the link between strategic aims and the provision of support services for at risk and potentially at risk groups, for example, ESOL students.

- (c) DfE Update: DfE are working on management of budget for 2020/21 and the options available within the funding envelope available. The Chair advised that he discussed the Governing Body vacancies with DfE and the feedback is that the earliest that a competition might be under way is early 2021.
- (d) Advertisement to begin recruitment of Chief Executive will be in Belfast Telegraph on Friday 13 December 2019 and Chair asked Governors to circulate the opportunity.

The Governing Body noted the items raised and the action taken by the Chair and Principal & Chief Executive.

### GB41 19/20 Strategic Action Framework

The Chair advised that the Belfast Met needed this document to support action by management and effective governance.

(a) Science, Engineering and Construction Curriculum Overview – Chris Corken, Head of Department of Science, Engineering and Construction;

The Governing Body discussed awareness of

- the wide range of offerings and business relationships among families; and,
- the range of skills and added-value that Belfast Met students offer among NI businesses.

Management provided some examples of engagement with SMEs on the added value that Belfast Met

(b) Business Development - Centre for Economic Development and Social Inclusion Curriculum Overview - Siobhan Lyons, Head of Business Development;

Governing Body welcomed the professional and comprehensive overviews and noted the level of partnership working across the business, which clearly demonstrated passion and commitment across all staff.

Management outlined the responsiveness that the College provides through close working with Curriculum Area Managers to identify capacity and build income generation capability.

Management advised that DfE define the priority sectors and this is reflected in the identification of hubs and the support that DfE provide across the curriculum offerings at various levels. The Governing Body noted the relationship between enrolment numbers and added value.

(c) Strategic Action Framework - Gillian Magee, Director of People, Policy and Planning.

The Governing Body advised that

- the unique approach developed by the Governing Body and Executive Team which led to the definition and communication of the Strategic Aims was consistently evidenced in the management presentations;
- management may wish to consider more flexible company structures to support delivery going forward; and,
- the challenges of maintaining relevance in the face of increasing complexity and competition.

The Governing Body approved the process to develop the Strategic Action Framework 2020/2024 that management proposed and asked management to support the Governing Body in the next stage of reviewing the objectives to support the direction of travel of the College in the next 5 years.

- (c) the sad loss of three students to suicide underscores the importance of this action being taken by the College;
- (d) areas of good practice include collaboration with partners across social services;
- (e) the potential for a review of the processes around Access NI assurances;
- (f) the potential training need for the Governing Body members.

The Governing Body **noted** the report and agreed that Governing Body members should be subject Access NI checks.
